



## From the Headmaster

I have very much enjoyed welcoming prospective students and their parents into School this week for our autumn open days. There is something rather wonderful about seeing Sir Thomas Rich's through their eyes as they experience the tour of the School and hear more about the opportunities on offer. I am extremely proud of our Observators and Year 10 tour guides who have been fantastic ambassadors for Sir Thomas Rich's this week enthusing our young visitors and offering them their own perspective of life at Rich's. My thanks to all the students who took part in the open day arrangements, and to teachers for welcoming everyone into their classrooms so readily.

### **Covid-19 Vaccination Programme Update**

As you are aware there has recently been a recommendation from the Chief Medical Officers (CMOs) that all children aged 12 to 15 should be offered a COVID-19 vaccination. The government has decided to go ahead with the offer of a vaccine to all 12 to 15-year-olds which will be delivered by local NHS services, through schools, in the same way as other vaccine programmes such as flu or HPV. They are recommending one dose for young people in this age group.

I would like to stress that this is a national directive and Sir Thomas Rich's is only providing the site to facilitate this offer. There will be no pressure or expectation at all from the School, indeed it is very important for the School to remain neutral in this matter, lest parents and students feel swayed to base their view on the School's stance.

The usual consent processes will apply with parents being asked to discuss the offer with their child and make an informed choice. I encourage you to speak to your child ahead of time so that there is agreement on consent by the date of the vaccination session. However, for the avoidance of any doubt, the vaccination is **not** mandatory and I can assure parents that if a child does not have parental consent and does not want to take the vaccine they will not receive it, and they will of course continue to attend school and participate in activities as usual. The NHS consent forms will be shared with you when they become available, most likely online, and the NHS will deal with collecting these in time for the vaccinations.

You may also find the following information useful:

- The School Age Immunisation Service (SAIS) is the provider of the programme, and will liaise with Sir Thomas Rich's with regards to a date and parental consent.
- Like all school-based vaccination programmes, the vaccine will be administered by trained healthcare professionals, following the usual approach to school-based immunisation.
- For students in Year 7 who turn 12 after the vaccination session date, those students who are absent or unwell on the date, those who change their mind about receiving the vaccine, or those who have recently had a Covid-19 infection, a follow-up date will be offered. It is anticipated that this will be delivered outside of school.
- All 16 and 17-year-olds will have already been offered the vaccine through the adult vaccination service. Some SAIS providers may have the capacity to offer the vaccination to 16 and 17-year-olds in school who have not yet taken up their first dose, but we do not yet know whether this will be the case at Rich's.
- At the moment, we do not know which of the four Covid-19 vaccines approved for use in the UK will be used, or when a second dose would be administered.

To help people access accurate information, the local NHS will be developing a dedicated page on the Gloucestershire NHS COVID-19 portal with factual information about the risks and benefits of the vaccine. There will also be a dedicated advice line and email address for parents or any young people who may wish to have a more detailed conversation. We will share these details as soon as we receive them.

In addition to the awarding of prizes, I will address the School and there will be the opportunity to hear from the Chairman of Governors and the School Captains. Please do join us virtually for what I hope will be an interesting occasion – not least as, this year, the event will be totally live!
