The form should be completed by **Friday 17 December 2021**.

Pupils who are thinking about studying a subject that they have not studied before in Key Stage 3 may wish to look at the school website to learn a bit more about what these subjects entail and can lead onto.

There are some restrictions in choices:

- Maths, English (Language and Literature) and Science (Separate Sciences or Double Award) are compulsory
- Pupils must study a Modern Foreign Language
- Unless opting for full course Religious Studies, pupils will also be required to take a Short Course RS qualification, sat at the end of Year 10
- Pupils may not choose both Business Studies and Economics
- Pupils may not choose both Art and Photography

I hope that this process is clear and reasonably straightforward.
