



## Examinations and post-examination.

Dear Parents

In our final assembly today, we reminded the boys of how proud we all were of them and that they were ready for the examinations to start.

### **Study Leave and Examinations**

Today is the last day of academic lessons for Year 11; pupils are welcome to attend their **normal scheduled lessons** from Thursday 8 May, and continue to use subject teachers to aid their revision. Pupils should not use other facilities within the school, including PSR, computer rooms, and the LRC without supervision or permission from a member of staff during lesson time.

All pupils who are on site to revise must firstly register with their tutor if they are in before 9am, or sign in at Reception if they come in later; this is so they are listed as present in School. If a pupil does decide to work in school, they **must wear school uniform**. Pupils must also sign out if they leave to go home early, and they will not be allowed to leave site and then return to school.

Some pupils in Year 11 have been recommended to attend school throughout the examination period to help support their revision. Again, these pupils will follow their timetable but will be able to get extra support from their teachers. Teachers are prepared for small group support sessions in their lessons to help.

When pupils report for examinations, **correct school uniform must be worn**, and appearance should be as indicated in the school rules. After an examination, if pupils want to stay on site, they should sign in at reception. Again, if they want to stay either to revise or for another examination, they would be expected to follow their timetable and not to leave site and return.

### **Post Examination Returning of Books**

**Pupils should collect a Clearance Certificate from Reception during their examinations.** The Clearance Certificate will need to be signed by each subject teacher when pupils have returned textbooks/resources to them.

The Clearance Certificate should then be signed by the Form Teacher and then handed back to Mrs Sally Walker at Reception.

Textbooks, resources, etc. must be returned to departments by **Friday 3 July**.

### **AN INVOICE WILL BE SENT HOME FOR BOOKS NOT RETURNED TO SCHOOL BY THIS DATE.**

Those pupils in **Year 11 who definitely know they will not be returning to STRS for Year 12** should also pay £5.00 on Scopay and get their Clearance Certificate signed by the Headmaster before handing back to Reception. This will enable us to post their GCSE examination certificates home in November/December 2025.

### **Examination Results**

**GCSE** results day is on **Thursday 20 August**. Pupils should come into school after 9.00am to collect their results. The Sixth Form Team will be available to advise on Sixth Form entry and progression pathways post-16.

If you know that you will not be able to come and collect the results, then you can request someone else to collect them or to have them posted. Please complete the following form on SharePoint and return to the exams office by 13 July.
